School Eligibility

For 2010/11: must attend All Souls, Assumption, Blessed Sacrament, Our Lady of Lourdes, St. Anthony's Sterling, St. Bernadette, St. Catherine of Siena, St. James, St. Therese, St. Vincent de Paul, Bishop Machebeuf High School, Regis Jesuit High School

Academic Eligibility

Must maintain an average to above average academic record (to be determined by the student's teachers).

Scholarships

Scholarships of up to \$3,000 will be awarded to high school students and up to \$1,800 will be awarded to grade school students per academic year. Scholarships are awarded for one year. Each family must reapply for funding each year.
